Employees Group Insurance Scheme-1984.

The amounts indicated in the tables have been worked out on the basis of following rate of interest per annum(compounded quarterly):-

3. While calculating the amount it has been assumed that full subscription has been recovered or will be recovered from the salary for the month in which he ceases to be in service, failing which should be deducted from the accumulated amounts payables.
