OFFICE MEMORANDUM

**Subject:** Grant of Interim Relief to the employees of the Government of Himachal Pradesh-drawal of arrears.

In continuation of this Department's Office Memorandums of even number dated 7<sup>th</sup> March, 2008 and 25<sup>th</sup> March, 2008, I am directed to say that the arrears on account of grant of Interim Relief to the employees of the State Government, for the period 1.11.2006 to 29.2.2008 could not be drawn on 31.3.2008 in some Departments as well as field offices. Now the Government has decided that the arrears may be drawn and credited to the General Provident Fund Account of the employees concerned. Arrears in respect of those employees who have retired or closed their GPF accounts by the time the arrears are drawn, may be paid to them in cash. In respect of employees who are governed under the Contributory Pension Scheme, the arrears may be paid in cash.



OFFICE MEMORANDUM

**Subject:** Grant of Interim Relief to the employees of the Government of Himachal Pradesh-Clarification thereof.

In continuation of this Department's Office Memorandum of even number dated 7<sup>th</sup> March, 2008, I am directed to say that it will be the responsibility of the concerned Drawing and Disbursing Officers in every Department to ensure that the arrears of the Interim Relief are drawn and credited to the General Provident Fund account of the concerned employees on or before 31<sup>st</sup> March, 2008, failing which the concerned Department will have to take prior permission of the Finance Department to draw Interim Relief payment/arrears.

It is further clarified that for such employees who have closed their GPF accounts by the date the arrears are drawn or employees who are governed under the Contributory Pension Scheme, the arrears of Interim Relief shall be paid in cash on or before 31.3.2008.
