OFFICE MEMORANDUM

Subject: Restoration of Commuted portion of pension.

The undersigned is directed to say that H.P. Government pensioners, who have commuted a portion of their pension, are entitled to the restoration of the commuted portion after attaining the age of 70 years or after the commuted value is repaid to the Government by way of reduced pension, whichever is later, in accordance with the provisions of this Department O.M. No:FIN(C)A(3)-6/81 dated 5.8.82 and 12.8.83.

Because of the specific mention of the age of 70 years quoted above, in the H.P. Government orders, the persons who take pre-mature retirement have to wait till the attainment of 70 years of age. This matter has been examined and the Governor of Himachal Pradesh is pleased to order that commuted portion of pension in the case of those employees, who seek pre-mature retirement or who are compulsorily retired by the Government and get a portion of their pension commuted before attaining the age of 59 years may be restored after 15 years of such commutation or after the pensioner concerned attains the age of 70 years, whichever is earlier. In other cases, the procedure for restoration
