Rationalisation of age limit at 25 years for the purpose Sub: of entitlement of family pension for sons &unmarried daughters of a Government servant.

The undersigned is directed to invite to a reference to this Department's O.M. No. Fin(C)A(3)-1/85 dated 19-7-1986 and to say that the age limit in case of unmarried daughterswas raised from 24 years to 30 years for purpose of entitlemen of family pension under C.C.S. (Pension) Rules, 1972 vide this Office Memorandum.

- In partial modification to these orders, the Governor Himachal Pradesh is pleased to decide that in order to have uniformity for grant of family pension, the sons and unmarried daughters of Government servants may continue to get family pension upto the age of 25 years as against the present age limit of 21 years and 30 years respectively, The provisions of rule 54(6)(ii) and (iii) of the CCS(Pension) Rules may be deemed to have been modified accordingly, Necessary amendment to these rules will be issued in due course.
- An unmarried daughter shall become ineligible for family pension from the date she gets married. Further, the family pension payable to a son or daughter shall be stopped if he or she starts earning his or her livelihood or attains 25 years of age whichever is earlier,
- These orders take effect from 6th August, 1987.
