OFFICE MEMORANDUM

Subject: Permanent transfer of Government servants to Autonomous bodies/Public sector undertakings and counting of service for the purpose of pension of employees of State Government and State Autonomous bodies under the State Government and Vice-versa parity in the matter of payment of pro-rata retirement benefits thereof - Guidelines for exceptions to the immediate absorption principles.

In continuation of this Office Memorandum No. 14-2/

Fin(REE), dated 8.7.1976 regarding permanent absorptions of Government employees in Autonomous bodies/Public Sector undertakings (copy enclosed for ready reference), the undersigned is

directed to say that the Govt. of India have further liberalised

the instructions in this behalf vide their O.M. No. 4(12)/85-P&PW dated 31-3-1987 ✓

No. 28016/5/85-Estt(C) dated 31-1-1986 ✓

No. 4/42/87-P&PW dated 19-4-1988 ✓

No. 4/42/87- (D) dated 29-1-1991 ✓

(copies of which are also enclosed). These instructions shall be applicable to the State Govt. employees and the employees working in State Public Sector undertakings/Autonomous bodies from the date of issue of these orders.

In this connection, it may also be mentioned that the H.P. State Govt. have entered into reciprocal arrangement with the Govt. of India vide O.M. of even No. dated 4-7-1986 and dt. 18-4-1988 (copy enclosed for ready reference) whereunder benefit of counting of service for purpose of pension of the employees of Central Govt. and Central Autonomous bodies seeking absorption in the Autonomous bodies under the State Govt. and vice-versa.




