Scheme for payment of monthly pension through the Public Sector Banks-Extension of such benefit to the pensioners of the Government of Assam drawing their monthly pension from the Breasuries/Sub-Treasuries of other States.

The undersigned is directed to invite a reference to this Department's Office Memorandum number Fin(C)B(M)=18/77 dated 17th February,1981, 20th August,1985 and 11th July,1986 on the above noted subject and to say that it has been decided that the pensioners of Assam Government who are drawing their pension from any Treasury/Sub-Treasury in Himachal Pradesh or want to draw pension through the Public Sector Banks under the scheme introduced with effect from 1st August,1978 subject to the following conditions

- The scheme for payment of pension through Public Sector Banks is also in force in the state to which the pensioner belongs.
- The facility will be provided through the same
  Public Sector Banks which have been shown in para-2
  of the scheme of Himachal Pradesh Government.
- The procedure for the switchover from the Tressury to the Banks for the purposes of pension will be the same as has been prescribed in the scheme interoduced by this Government.
- by the bank in the payment scrolls against the

State Governments to whom the payment is debitable. The payment will, however, be initially taken against the cash balance of this Govt.

v)

The payment made on behalf of other State Govtewill be consolidated by the Accountant General,
Himachal Prodesh, Shimla-3, with reference to the
payment scrolls received by him through concerned
District Treasuries. He will also be responsible
for obtaining re-imbursement of the amounts so
paid from the concerned Accountant General. The
present instructions for carrying out inter-state
adjustments will mutatis-mutandis be observed in
this respect.

2. These orders take effect from the date of issue of this Office Memorandum.
