NOTIFICATION

S.O. No.....In exercise of the powers conferred by the proviso to article 309 and clause (5) of article 148 of the Constitution and after consultation with the Comptroller and Auditor General of India in relation to persons serving in the Indian Audit and Accounts Department, The President hereby makes the following rules further to amend the Central Civil Services (Pension) Rules, 1972, namely:-

1. (1) These rules may be called the Central Civil Services (Pension) 2nd Amendment Rule, 1997.
- (2) They shall come into force on the date of their publication in the Official Gazette.
2. In the Central Civil Services (Pension) Rules, 1972,
  - (a) in rule 37, for sub-rule (1), the following sub-rule shall be substituted, namely:-

"(1) A Government Servant who has been permitted to be absorbed in a Service or post in or under a Corporation or Company wholly or substantially owned or controlled by the Central Government or a State Government or in or under a body controlled or financed by the Central Government or a State Government, shall be deemed to have retired from service from the date of such absorption and subject to sub-rule (3), he shall be eligible to receive retirement benefits, if any, from such date as may be determined, in

accordance with the orders of the Central Government applicable to him."

(b) rule 37-A shall be omitted;

(c) in rule 55-A, sub-rule (iii) shall be omitted.
