OFFICE MEMORANDUM

Subject:- Restoration of commuted portion of pension.

Under the existing rules for commutation of pension, a Government servant is entitled to a lump sum payment if he surrenders permanently a portion of his pension, but not exceeding 1/3rd thereof. This commutation is permissible immediately after retirement or at any time thereafter at the option of the retiree.

The State Pensioners and their association have been repeatedly requesting the Government for restoration of commuted portion of their pension. The Government have carefully considered the matter. Having regard to the liberalisation of the pension Rules made in recent times, and the difficulties being experienced by old pensioners due to acute inflationary trend, the Governor, Himachal Pradesh, is pleased to order that in cases where a pensioner commutes a part of his pension and receive lump sum in lieu thereof, may be allowed restoration of the commuted portion, after he has attained the age of 70 years.

2. This decision will have effect from 1st April, 1982 and would apply in the case of all Himachal Pradesh Government Pensioners who have already commuted a portion of their pension and who may hereafter get a part of their pension commuted on their retirement.
