Sr. No.		
1.	Upto five days	Normal
2.	For more than five days and upto 15 days	Double the normal charges of that category
3.	More than fifteen days and upto 30 days	Three times of the normal charges of that category
4.	More than 30 days	Four times of the normal charges of that category.

3. The concerned Manager of the Bhawan will ensure that only those persons in whose names rooms have been reserved on concessional rates should be allowed to stay in these Bhawans. There will not be any occupancy by proxy. The HPTDC also to ensure quality facilities to the occupants.
