4. The room tariff for staying in Circuit House/Rest House for Officers/Officials of State Govt. at the time of transfer to the station will be as under:-

1.	For one week	Normal
2.	For 30 days after one week	Double the normal charges of that category
3.	Period beyond above	Three times of the normal charges of that category

For ensuring the proper charges for the respective category as per norms proposed above the incharge of Circuit House/Rest House will ensure that only those persons in whose names rooms have been reserved on concessional rates should be allowed to stay in these houses. There will not be any occupancy by proxy. The quality facilities to the occupants will also be ensured.
