Applications on the prescribed format are invited from the eligible & desirous bonafide residents of Himachal Pradesh for recruitment to **01 (One) Post of Mali-cum-Chowkidar (Unreserved)** and **01 (One) post of Peon (OBC category)** purely on daily wages basis in the office of the Divisional Commissioner, Shimla Division, Shimla-2 Himachal Pradesh. <b>Desirable Qualification</b>	Knowledge of customs, manner and dialects of H.P. and suitability for appointment in the peculiar conditions prevailing in the Pradesh.
<b>Other eligibility criteria</b>	1. The age of candidates should be between 18 to 45 years as on 01-01-2019. 2. Provided further that upper age limit is relaxable for Scheduled Castes/Schedule Tribes/Other categories of persons to the extent permissible under the general or special order (s) of the Himachal Pradesh Govt.
