The Government of Himachal Pradesh proposes to fill up one post of Member in the Himachal Pradesh State Waqf Tribunal at Dharamshala, District Kangra, Himachal Pradesh, constituted vide this department Notification No. C(F)(Waqf)1-1/2014 dated 6th January, 2016 from amongst the Advocates having knowledge of Muslim law and jurisprudence. The desirous and eligible advocates are required to submit their applications in the prescribed format which is available on the official website of the Himachal Pradesh Revenue Department (<https://himachal.nic.in/Revenue>) alongwith requisite degrees/documents. The application must reach in the office of the **Additional Chief Secretary (Revenue) to the Government of Himachal Pradesh, Shimla- 171002**, on or before 18th April, 2019 up-to 5:00 PM, positively. The applications received after due date or incomplete or not in the prescribed format or without accompanying the requisite documents shall be liable to be straightway rejected without assigning any reasons whatsoever.

- Age:-** Between 45 and 58 years. (The candidate applying for the post must not be less than 45 years of age on the date of submission of his/her application).
- Qualifications:-**
- (i) Must possess a degree in law and having knowledge of Muslim Law and jurisprudence.
 - (ii) Preference shall be given to the Senior Advocate having of the Muslim Law, Waqf matters and having experience not less than 20 years.

Terms of office:- The term of office shall be for a period of three years which may be extended further for a maximum period of two years.


Pay and allowances:- The Member shall be entitled to get fixed remuneration of Rs. 75,000/-p.m.

Mode of Selection:- The Selection of candidates shall be made by the Committee constituted by the Government in accordance with their performance as an Advocate in various courts.

Other Conditions:- An advocate appointed as a Member shall be deemed to be a public servant and shall be governed by the terms and conditions as may be applicable. Advocate appointed as a Member shall not be entitled to practice in any courts of Law till he/she holds office as a Member of Waqf Tribunal.
