working in the State of Himachal Pradesh.


Sir/Madam,

In continuation to this Department Notification No. Rev-A (E) 3-169/2011-Loose dated 03.04.2017 on the subject cited above and to say that an announcement to increase the Honorarium given to all Numberdars by Rs.500 Per Month was made by the Hon'ble Chief Minister, Himachal Pradesh while presenting the budget for the Financial year, 2020-2021. The budget for the year, 2020-2021 has been passed by the Vidhan Sabha.

The matter in question was under active consideration of the Government. Now, it has been approved to increase Honorarium to all Numberdars working in the State of Himachal Pradesh from Rs. 1500/- to Rs. 2000/- Per Month w.e.f. 01.04.2020 without any other financial benefits i.e. 50% Pachotra.

You are, therefore, requested to take further appropriate necessary action in the matter accordingly. It may also be ensured that the payment on account of enhancement of the aforesaid emoluments may be released to all Numberdars in the 1<sup>st</sup> week of April positively.
