2. The Committee will have to collect all cases of compassionate appointment falling under the ambit of present policy of Finance Department from all Head of the Departments of Revenue Department and make an acumen scrutiny of each cases keeping in view of the policy of Finance Department. Added to this, a combined seniority of all eligible applicants of Revenue Department must be devised. The order of seniority of an applicant/claimant to job must be determined in accordance with the date of demise of employee.

Further, recommendation to the Government must be made as per given format:-

3. The services of the staff posted in Directorate of Consolidation of Holdings will be taken for this purpose, rest if required, will have to be managed by internalization of staff.

All of the Head of the Departments of Revenue Department will be responsible to ensure to supply all cases of Compassionate Employment in complete manner to the O/o Director, Land Records/Consolidation of Holdings, within a maximum time period of 15 days. Any document (s) relating to any case, if has been

Asked from the Government level; the H.O.Ds. will have to supply the same directly to the O/o Consolidation of Holdings making therein specific mention of the case with specific background so that Committee could get easily apprised.

5. The Committee will submit its comprehensive report/recommendation to the Government within 30 days. However, weekly progress in this behalf have to be ensured to be sent by the Member Secretary invariably in every week.


