# Subject:- Online Factory Registration under Factories Act, 1948

Please refer to this office letter of even no. L&E (Fac) 9-281/07 dated 31.07.2014 on the subject cited above. In this context, it is once again reiterated that the department has operationalised the software namely OFRIS (On line Factory Registration Information System) with effect from 01.08.2014. The said software can be accessed on admis.hp.nic.in/ofris. As per earlier letter referred above, the department will receive online applications w.e.f. 01.08.2014 for approval of building plans, registration and renewal of licence (year 2015 onwards). For this purpose, the occupier has to register himself one time in the said software in order to create authorized login and password. The units which are already registered have to apply for renewal of licence for 2015 only online and no manual application will be accepted for renewal of factory licence for the year 2015.

The already registered units are also required to get themselves registered so as to create authorized login and password and opt the option **Licence already issued**.

(Form 3) through OFRIS so as to get the system generated number and also for tracking status of application in future which will facilitate them for applying online renewal for the year 2015. The said task was required to be completed by 15.09.2014. But till date progress appears to be quiet slow.

It is also informed that last date for submission of renewal application as per past practice is 31.10.2014. It is therefore, once again requested that your member industries may once again be advised to ensure onetime account registration and enter the necessary details through OFRIS so that they can submit their application for renewal of licence before 31.10.2014 so as to avoid last minute rush and save themselves from congestion in the website (OFRIS) as well as avoiding of payment of late fee. The process of one time account registration and backlog entry regarding already approved building plans, factory registration in respect of already registered units may be positively completed by 10.10.2014.
