In exercise of the powers conferred by section 112 read with section 115 of the Factories Act, 1948, (Act No. 63 of 1948), the Governor, Himachal Pradesh proposes to make the following rules further to amend the Himachal Pradesh Factories Rules 1950 notified vide Industries Department Notification No. D. 80-12-48.III dated 6<sup>th</sup> May, 1952 and the same are hereby published in the Rajpatra, Himachal Pradesh for general information of the public;

If any person likely to be affected by the draft rules has any objection(s) or suggestion(s) in respect of these rules, he may send the same to the Principal Secretary (L&E) to the Government of H.P., Shimla-2, within 45 days from the date of publication of the draft rules in the Rajpatra, Himachal Pradesh;

Objection(s) or suggestion(s), if any, received within the period specified above, shall be considered by the State Government before finalising the draft rules, namely:-

Short title and commencement.

- 1. (1) These rules may be called the Himachal Pradesh Factories (Amendment) Rules, 2016.
  - (2) They shall come into force from the date of publication in the Rajpatra, Himachal Pradesh.
- 2. In rule 5 of the Himachal Pradesh Factories Rules, 1950 (hereafter referred to as the said rules),
  - (a) in sub-rule (1), after the words "or five years", the words "or ten years" shall be inserted:
  - (b) in sub-rule (2) for the words and sign "five years, the licence fee shall be five times" the words and signs "five years or ten years, the licence fee shall be five times or ten times, as the case may be," shall be substituted; and
  - (c) in sub-rule (3), after the words "or five years", the words "or ten years" shall be inserted.
