NOTIFICATION

Whereas, the proposal regarding amendment in the Himachal Pradesh Factories Rules 1950 notified vide Industries Department Notification No. D. 80-12-48.III dated 6th May, 1952 was published in the Rajpatra, Himachal Pradesh, vide this Department notification of even number dated 18th July, 2016 for inviting objection(s)/suggestion(s) from person(s) likely to be affected thereby as required under the provisions of section 112 read with section 115 of the Factories Act, 1948, (Act No. 63 of 1948) within a period of 45 days from the date of its publication.

And whereas, no objection(s)/ suggestion(s) have been received in this behalf within the above stipulated period;

Now, therefore, the Governor, Himachal Pradesh, in exercise of the powers conferred by section 112 read with section 115 of the Factories Act, 1948, (Act No. 63 of 1948), is pleased to extend the provisions of the above Act to all the industrial establishments in Himachal Pradesh.

Short title and commencement.

Amendment of rule 5.

- (1) These rules may be called the Himachal Pradesh Factories (Amendment) Rules, 2016.
 - (2) They shall come into force from the date of publication in the Rajpatra, Himachal Pradesh.
- In rule 5 of the Himachal Pradesh Factories Rules, 1950 (hereafter referred to as the said rules).
 - (a) in sub-rule (1), after the words "or five years", the words "or ten years' shall be inserted;
 - (b) in sub-rule (2) for the words and sign 'five years, the licence fee shall be five times' the words and signs "five years or ten years, the licence fee shall be five times or ten times, as the case may be;" shall be substituted; and
 - (c) in sub-rule (3), after the words 'or five years', the words 'or ten years' shall be inserted.

Amendment of rule 7.

- 3. (a) in sub-rule (2), after the words "or five years", the words "or ten years" shall be inserted;
 - (b) in sub-rule(3), for the words and sign "made for five years, the renewal fee shall be five times", the words and signs "made for five years or ten years, the renewal fee shall be five times or ten times, as the case may be," shall be substituted; and
 - (c) in the proviso to sub-rule(3), after the words "or five years", the words "or ten years" shall be inserted.
