
In this regard, your attention is drawn to the provision of Section 135-B of Representation of the People Act, 1951. For your ready reference the provision of Section 135-B, is as under:-

- "135-B Grant of paid holiday to employees on the day of poll--- (I) Every person employed in any business, trade, Industrial undertaking or any other establishment and entitled to vote at an election to the House of the People or the Legislative Assembly of a State shall, on the day of poll, be granted a holiday.
- (2). No deduction or abatement of the wages of any such person shall be made on account of holiday having being granted in accordance with sub section (I) and if such person is employed on the basis that he would not ordinarily receive wages for such a day, he shall nonetheless be paid for such day the wages he would have drawn had not a holiday been granted to him on that day.
- (3). If an employer contravenes the provisions of sub section (I) or sub section (2), then such employer shall be punishable with fine which may extend to five Hundred Rupees.
- (4). This section shall not apply to any elector whose absence may cause danger or substantial loss in respect of the employment in which he is engaged."

You are therefore, requested to bring the said provisions to the notice of occupiers/managers of factories/Industrial establishments situated under your jurisdiction and direct them to grant additional paid holiday to the workers working in their factories as per section 135-B of Act ibid on 19.05.2019 in Himachal Pradesh as well as for the date(s) of poll mentioned above in the areas of Himachal Pradesh bordering with neighboring states in order to exercise their right of

franchise. It is also clarified that even those electros including casual workers working outside the constituency concerned would be entitled to benefit of paid holiday extended under Section 135(B)(I) of the Representation of People.
