AUCTION NOTICE

It is for the information of general public that the public auction of the unserviceable general stores, shall take place on 21-09-2015 at 11.00 AM in the premises of HP Institute of Public Administration, Fairlawn, Shimla-171012.

The interested parties may contract Sh. Karam Chand, Senior Assistant-cum-Store Keeper (Mobile No. 9805683243) to inspect the materials.

Each bidder shall have to deposit Rs. 1000/- (Rupees One Thousand only) towards security with the cashier of the office of the undersigned with proper receipt before taking part in the auction, the receipt of which will be produced by the bidder before the authorized officer at the time of auction. The amount of security shall be refunded to the unsuccessful bidders and the same shall be adjusted towards the final payment of the bid money in respect of successful bidder.

The successful bidder, whose offer will be accepted, shall be required to deposit 25% of the bid money immediately on fall of hammer, failing which the undersigned will have the right to forfeit the security money. The bidder shall have to remit the balance amount within seven days from the auction. The Sale Release Order shall only be issued after receiving the balance 75% of the bid money. In case the bidder, who has deposited 25% of bid money, fails to deposit the balance 75% of the bid money within the stipulated period, the 25% of the bid money and security so deposited with the Institute will be forfeited. The bidder shall have to lift the material within three days from the issue of Sale Release Order. In case the bidder after remitting the full amount fails to lift the material within stipulated time the undersigned will have the right to re-auction such materials at bidder's risk and cost.

The undersigned reserves the right to accept or reject all or any bid and to cancel or postpone the auction without assigning any reason.
