## Comment on the following with relevant ruling-

- (a) Mr. 'A' was on earned leave from 25<sup>th</sup> Dec. 2013 to 15<sup>th</sup> Fe b., 2014. His annual increment, which was due on 1<sup>st</sup> Jan., 2014 was allowed on 16<sup>th</sup> Feb., 2014 on the date he joined the office after availing the leave. His next increment was allowed on 1<sup>st</sup> Feb., 2015 saying that it has been deferred permanently.
- (b) Ms. 'B' was not allowed maternity leave for her delivery saying that maternity leave was not admissible to unmarried ladies.
- (c) Mr. 'C' on his transfer was relieved from Shimla on 4<sup>th</sup> Sept. (AN) with the orders that 12 days joining time will be admissible to him to join at Chamba. He joined at the new station on 20<sup>th</sup> Sept.,(FN) saying that 12 days counted from 7<sup>th</sup> to 18<sup>th</sup> Sept. by prefixing Sunday and holiday falling 5<sup>th</sup> 6<sup>th</sup> Sept and suffixing the gazetted holiday falling on (A) September.
- (d) One Mr.'D' expired while in service. He was survived by his wife, son (18 yrs) and aged mother. No nomination for payment of the gratuity was available and the authorities disbursed it among all the three family members in equal share.
- (e) Mr. 'E' proceeded on an urgent duty from Bilaspur to Mandi on 15<sup>th</sup> March at 5.00 o'clock in the afternoon and after performing the assigned duty, arrived back at his HQ at 7 o'clock in the morning next day. He was allowed only one daily in his TA claim saying that his absence from HQ was for only one day.
