The new post involves assumption of duties and responsibilities of greater importance. The Government servant files an option to get his pay fixed on the higher post from the date he would have earned his annual increment in the lower post. He has not received any benefit under Assured Career Progression Scheme. Fis his pay and determined date of next increment on the higher post.
