He was promoted to the post of Under Secretary in the same Pay Band with Grade Pay 6600/-on 15.07.2016 on Adhoc basis. He was promoted on regular basis on the same post with effect from 26.12.2016. Fix his pay on different occasions which is most beneficial to him.

- Q. No. III: Distinguish between:
 - (i) 'Re-employment' and 'extension in service.'
 - (ii) 'Retirement Gratuity' and Service Gratuity'.
 - (iii) Stoppage of 'One Increment' and 'Next Increment'.
 - (iv) Dies-non' and Break in Service?
 - (v) Reduction to 'Lower stage' in the time scale of pay and reduction to a 'Lower Time scale' of pay.

- Q. No. IV: Mr. 'A' superannuated on 31.12.2016 from the post of Under Secretary. He joined government service on 25.08.1983. His basic pay on the date superannuation was Rs.41180 (Rs.33580 plus 7600 GP) in the pay band Rs.15600-39100 +7600 GP and Dearness Allowance on the date of retirement was 130%. He had 300+14 days of Earned Leave and 290 days of HPL at his credit. Calculate;
 - (i) Pension.
 - (ii) Retirement Gratuity.
 - (iii) Commutation Value at maximum admissible amount of pension.
 - (iv) Leave encashment.
 - (v) Family pension if his death occurred within one month of his superannuation.

(i) A government servant applied for advance from GPF for higher education of his son who is pursuing professional course of studies from a private university but authorities refused that it is not admissible for a course of study in a private university.

(ii) Period of service which count for increment and the periods which do

(iii) A government servant applied for 100 days of Extra Ordinary Leave but his application was rejected and he was advised to apply for Earned Leave as he had 150 EL at his credit.

(iv) A government servant superannuated during the currency of disciplinary proceedings for major penalty against him. How and when his retirement benefits including leave encashment would be settled?
