A Govt. Servant placed under suspension refuses to pay for Recovery of:-

- i) Income Tax from his Subsistance Allowance;
- ii) Amount due on Court attachments: \*
- iii) Contribiutions towards HP Govt. Employees' Group Insurance Scheme.
