(i) "Fee" and "Honorarium",

(ii) "Presumptive Pay" and "Substantive Pay",

(iii) "Daily Allowance" and "Mileage Allowance",

(v) "Compassionate Allowance" and "Compensation Pension".

Q.No.5: Mr. "X" working as Superintendent Gr. II under H.P. Government Department and drawing Basic Pay of Rs. 26,450 in the Pay Band 15600-39100 + 4800 Grade Pay with effect from 1<sup>st</sup> December, 2015 was promoted to the post of Superintendent Gr.I on adhoc basis on 11.05.2016 carrying the duties and responsibilities of greater importance in the same Pay Band but with the Grade Pay of Rs. 5400. He was promoted on regular basis on the same post on 16.11.2016. He opted for fixation of his pay in the higher post of Superintendent Gr.I from the date of accrual of his next increment in the lower post of Superintendent Gr.II. Fix his pay in the higher post of Superintendent Gr.I on adhoc basis and on regular basis. Also indicate the date of next increment in both the cases.

He was drawing Basic Pay of RS. 19,460 (Rs. 15,060+4,400) in the Pay Band of Rs. 10,300-34800+ 4,400 Grade Pay w.e.f. 01.05.2016. The rate of Dearness Allowance at the time of retirement was 130%. Calculate:
  - (i) Net Qualifying Service,
  - (ii) Pension admissible,
  - (iii) Amount of Retirement Gratuity admissible,
  - (iv) Amount of Pension Commutation and
  - (v) Family Pension on enhanced rate and normal rate in case of death of the pensioner.
