- c. How interest accrued on the unspent amount of Grant in aid provided by the Centre/State Government to a Public Sector Undertaking be treated in accounts?
- d. In what manner Accrual Accounting is better for Government Department involved implementation of Externally Aided Projects?

- c. Mr. X was treated as Dies non for 28.09.2018 but paid salary as the bill was cleared by the Treasury before that.
- d. Subsistence allowance to a Govt. servant under suspension was paid after deducting G.P.F. subscription as well as refund of advance taken from G.P.F. and the Govt. servant made a representation that the action is not covered under the Rules.
