I. Sealed quotations are hereby invited from the registered firms for the providing of Taxi Service to be used as and when required by HIPA as per description given in the **Annexure-"A"** to this document. You are requested to quote your most competitive prices please.

II. Your quotation duly sealed should reach in the office the Director, Himachal Pradesh Institute of Public Administration, Fairlawns, Shimla-171012 by **04.02.2020 latest by 03.00 PM** and the technical bid will be opened on the same day **at 03.30PM** in the presence of quoters or their authorized representatives whosoever may like to be present at that time. Financial bids of only those firms which qualify in the technical bid will be opened on later date.

III. The quoters shall have to furnish the offer in two envelopes:

**(a) Envelope-I (Technical Bid) should contain following documents:**

1. Earnest money amounting to Rs. 10,000/- in the shape of Bank draft of any scheduled bank in the name of the Director, HIPA, Fairlawns, Shimla-12 payable at Shimla
2. A copy of the PAN of the firm.
3. Authorization Letter issued by the competent authority to a person in this behalf who has signed the Quotation in case the quotation is signed by other than Proprietor/Authorised signatory.
4. A copy of experience of at least two years of providing satisfactory Taxi Services of at least 2Nos. taxis to any govt /semi govt. Organization during the period 2016-17, 2017-18 and 2018-19.
5. **Original quotation form duly signed and stamped every page by the authorized signatory in token of acceptance of the terms and conditions of the quotation letter.**
6. Copy of GST number.
7. Cost of the tender document amounting to Rs.500/-(Rupees five hundred only) in the shape of Bank Draft of any scheduled bank in the name of the Director, HIPA, Fairlawns, Shimla-12 payable at Shimla, if downloaded from website. Tender document can also be obtained from cashier of this office by paying / depositing necessary fee of Rs.500/- with cashier .

**(b) Envelop-II (Financial Bid) should contain the rates quoted as per Annexure-'A' of the Quotation Document. Financial Bid should not be enclosed in the Technical Bid Envelop.**

**(c) Financial & Technical bid should be put into bigger envelop and Word "Quotations for providing Taxi Services to HIPA on 04.02.2020 at 03.00 PM shall be superscripted on the top of the Envelop.**

**VI. Terms and Conditions: -**

1. The amount of earnest money in form other than mentioned above shall not be accepted. The earnest money of successful quoters shall be retained as security till the faithful execution/ completion of the contract. No interest shall be payable on the earnest money/ security/deposit. Earnest money will be refunded in the event of non-qualifying or the non-acceptance of quotation.
2. Conditional quotations and quotations without earnest money shall not be entertained.
3. The demand for a Taxi may arise day and night 24x7 any time.




4. In case of failure to provide the Taxi continuously for two occasions, the contract will be terminated and the security shall be forfeited.
5. In case of deficiency such as condition of the Taxi and behaviour/contract of the Driver, penalty of Rs.500/- will be deducted from the bill.
6. The vehicle should have all necessary accessories such as AC, Heater etc.
7. The vehicles shall have to be neat and clean and the behavior of the driver should be courteous.
8. The rates should be quoted strictly on the prescribed format i.e. Annexure "A" enclosed with the quotation document duly signed by the supplier or quoters. Telegraphic quotations and quotations not on the prescribed form shall not be entertained.
9. The quotations having cutting/poor writing / deficient of required documents / information will not be entertained.
10. Vehicles to be provided should be not more than 2 years old.
11. The undersigned reserves the right to accept or reject all or any quotation without assigning any reason whatsoever at any stage.
12. The validity of the quotation should be at least for not less than 60 days from the date of opening of quotation. No request for the increase of rates will be entertained during the period of contract.
13. All liabilities regarding vehicles hired will be that of the owner/firms as per the provisions of the Motor Vehicle Act 1988.
14. The Drivers of the vehicles should possess the valid driving license as per Motor Vehicle Act 1988 and should be in proper dress.
15. In case the conduct & service of the Driver is not found upto mark the firm/individual shall have to replace the driver immediately.
16. Toll Taxes/Entry Fee/Green Fee should be paid by the contractor.
17. The quotation will be evaluated on consolidated basis.
18. The rates should be quoted in Indian Rupees only.
19. The Institute will assign the contract to the bidder whose bid has been determined to be substantially responsive and who offered the lowest evaluated price.
20. The contract will be for a period of one year initially and can be extended further on satisfactory completion on mutual agreement.
21. All Government Levies and Taxes such TDS etc. will be deducted from the bill of the contractor.
22. The Earnest Money of the successful Bidder will be retained as Security which will be refunded on completion of the successful contract without interest.
23. The Director, HIPA shall not be in any manner concerned with the internal affairs of the quoters i.e. dispute and dissolution etc. or affairs concerning any other third party that the firm may be having.
24. Failure to discharge the contractual obligations by the firm in satisfactory manner, will lead to termination of the contract any time before the completion of the contract period with forfeiture of the security deposit and debarring of the firm from any participation in any tender and quotation process of the institution for a period of 2 years.
25. Payment shall be released after the receipt of the verified bill in the office within fifteen days ~~subject to the condition~~ the submitted bill is in order alongwith a copy of the Log Book of the concerned period((in case of monthly hiring).
26. Any dispute is subject to the jurisdiction of Hon'ble High Court of H.P. at Shimla only.

27. All expenses of any kind such repairs; POL, Insurance premium etc will be the sole responsibilities of the contractor.
28. In case of holiday on the date of opening of the quotations, the quotations shall be received and opened on the next working day at the same scheduled time & venue.
29. The Director, HIPA and Or his Representative also reserves the right to inspect the vehicle at any time anywhere.
30. Quotation found not in the proper Quotation form or deficient of required information/documents shall be considered as non-responsive and shall rejected straightway .
31. The Director, HIPA, Fairlawns, Shimla-12 reserves the right to cancel the process at any time without assigning any reason.
32. The terms and conditions mentioned above shall be binding and operative between the firm and the Director, HIPA, Shimla-12 will construe as contract for the taxi services of this Institute.
33. The successful bidder shall have to enter into an agreement with the Director, HIPA, Fairlwns, Shimla-171012 on Rs. 10/- Non judicial stamp paper for acceptance of the terms and conditions of the Contract.
