## Q.No.1 Answer the following citing relevant provisions of law:-

- Can an alcoholic beverage prepared without addition of sugar and hops may be called beer?
- 2. "Brewery only includes the premises where beer is manufactured and does not include places in that premises where beer is stored or wherefrom it is issued." Is the statement correct or not?
- 3. Whether any admixture containing sugar which can be fermented can be called molasses or such an admixture containing fermentable sugar has to satisfy some other conditions to be called molasses?
- 4. What are the conditions required to be fulfilled by an amendment or order issued under the H.P. Excise Act, 2011 to be called **notification**?
- 5. Name the document that actually authorizes the removal or transportation of liquor?
- 6. Does a carriage by cattle capable of being used as a conveyance for movement qualify to be called **vehicle** under the H.P. Excise Act, 2011?
- Name the document authorizing possession of liquor exceeding the limit of retail-sale permit provided under the H.P. Excise Act, 2011.
- 8. Name the two licenses granted by way of allotment that authorize retail sale of country liquor and IMFS/BIO in the rural areas. Which of these two licenses authorize consumption of country liquor both on and off the licensed premises?

- 9. Name the license that authorizes manufacture and retail sale of Country Fermented Liquor under the H.P. Excise Act, 2011. Is this license a fixed fee granted by way of allotment?
- 10. Define "commercial quantity", in relation to narcotic drugs and psychotropic substances. Can this quantity be fixed by the State Govt.?

- How many bulk litres & proof litres of liquor will be contained in one case of Indian made foreign spirit (IMFS) containing 24 Pints? Each pint measures 375 mls and contains liquor with strength 25 degree under proof.
- ii. Calculate the **retail excise duty** due on one case of IMFS described in Q.No. 8(i) if the EDP for the same is Rs. 999/-
- iii. How many bulk litres & proof litres of liquor will be contained in one case of country liquor containing 50 nips? Each quart measures 180 mls and contains liquor with strength 40 degree under proof.
- iv. Calculate the **excise duty** due on one case of country liquor described in Q.No. 8(iii).
- v. Calculate the **excise duty** on one case of beer containing 12 bottles measuring 650 ml each. The alcoholic content of the beer exceeds 5%.
- vi. Calculate the **excise duty** on one case of wine containing 12 bottles measuring 750 mls each manufactured in the State of H.P. The wine contains proof spirit upto 20%.
- vii. What are the licensed sale hours for a L-14 vend and a bar holding license in form L-4A & L-5A ?
- viii. Name four areas of the State wherein licenses in form L-20-C and L-20-D for the manufacture and possession of country fermented liquor or country distilled liquor for home consumption can be issued.
- ix. What is the intent and purpose behind enactment of Narcotic Drugs and Psychotropic Substances Act, 1985?
- x. What are the current rates of Export Fee for IMFS and ENA?
