- Q.No.1** An Assistant in H.P. Secretariat is drawing a Basic Pay of Rs. 28200+4400 Grade Pay on 01.01.2015 with annual increment falling on 01.07.2015 was promoted to the post of Superintendent Ex-cadre in the Pay Band of Rs. 10300-34800+4800 GP w.e.f. 01.09.2016. He was promoted to the post of Superintendent on regular basis w.e.f. 05.10.2018 carrying the Pay Band of Rs. 10300-34800 +4800 GP and retired from service on 31.12.2019. Determine his pay on the date of his retirement. (20)

- b) What conditions are to be satisfied before sanctioning the Honorarium and also explain the cases in which honorarium should not be sanctioned? (10)

- (b) What are the roles and responsibilities of DDOs in respect of processing and disbursing of Salary? (10)

- (i) Personal Pay and Special Pay.
 - (ii) Compensation pension & Compulsory retirement pension.

- Q.No.6** What are the various stages in major and minor penalty proceedings? (20)
- Q.No.7** (a) What are the TA entitlements of Government servant on his retirement? Whether TA advance is admissible to a Government servant for journeys after his retirement? (8+2=10)
- (b) What are the conditions for the grant of Commuted leave and salary admissible during this leave? (10)
- Q.No.8** Comment on following:
- (i) The competent authority sanctioned maternity leave to an Unmarried female Government servant.
- (ii) An Officer leaves his headquarter at 9.30 hours and returns to the headquarter at 19.30 hrs on the same day after visiting a place which is 50 km from the headquarter. He claimed full DA for that day.
- (iii) The arrear claim of a Government servant was presented to the Treasury after 18 months by the DDO.
- (iv) A Government servant after retirement applied for the commutation of half the pension authorised to him and the lumpsum payment was paid to him accordingly.
- (v) An amount of Rs.15000 on account of recovery of loss to the Government for which a Government servant was responsible was recovered from his Subsistence Allowance.
- (vi) A Govt. servant was transferred from Shimla to Hamirpur at his own request and no joining time was allowed to him.
- (vii) A Government servant on tour to Shimla had to extend his stay for two days on account of absence of train services due to heavy snowfall. Is he eligible to claim DA for the two days of extended halt?
- (viii) On reinstatement, full pay and allowances were paid to a Government servant for the period of suspension on the ground that the disciplinary proceedings ended in the imposition of a minor penalty of 'Censure' only. (2.5x8=20)
