- II. Who can be appointed as a Special Police Officer in the State of HP under which provision and by whom?
- III. What is the composition of the Juvenile Justice Board?
- IV. Can son(s) and/or daughter(s) born out of extra marital relationship be termed as "dependent" under the Himachal Pradesh Maintenance of Parents and Dependants Act, 2001?
- V. What is the upper time limit for which government land can be leased out under the HP Lease Rules 2013?
- VI. Can Gram Sabhas be constituted and their meetings called at the Gram Panchayat level for the purpose of Forests Rights Act (FRA)?
- VII. What are the criteria and evidence required for a Forest Dwelling Scheduled Tribe (FDST) to claim rights under FRA?
