Q.No.-1 On 19-01-16, one Kamal Bir Singh lodged a report at Police Station Shimla (East) against Jitinder Kumar S/o Sh. Surjan Singh Kukreja who is having his house above his house. It is alleged that Jitinder Kukreja illegally and unauthorisedly extended his construction over the roof of Kamal Bir Singh (complainant). It is also alleged that Jitinder Kumar often quarrels with him & it is apprehended that it may result in a serious fight with him. After conducting enquiry, the police presented Kalandra u/s 107/150 Cr.P.C. (Mark B1 & B2) against Jitinder Kukreja before Ld. S.D.M. Shimla along with statements mark B3 & B4.

(a) On the bases of mark B1 to B4 draw a notice u/s 111 Cr.P.C.

(b) Considering mark B1 to B4 to be correct, write a detailed order asking Jitinder Kumar to furnish a bond with one surety of the like amount to keep peace & be of good behavior for one year.

(c) Whether S.D.M. Shimla can ask respondent to execute a bond with one surety till enquiry is concluded.

Q.No.2 On 7-9-11, at about 3.30 P.M. Vinay Bhagnal & Anish were present at Kotla Nallah Solan (H.P.) where Kuldeep Kumar, Kapil Shandil, Dharmender Thakur & Manjeet Parkash were also present and they voluntarily gave beating to them and caused injuries on their person and also broke the glass panes of their vehicle bearing No.DL-7CC-8657. Through a written complaint, Vinay Bhagnal reported the matter at Police Station Sadar Solan. On this F.I.R. was registered. During investigation spot map was prepared, damaged car was taken into possession, both Vinay Bhagnal & Anish were got medically examined and injuries on their person were found to be simple in nature & Statements of witnesses were recorded u/s 161 Cr.P.C. After completion of investigation challan was presented before the Court.

Paper 5 : Revenue Case

1. The current jamabandi of Village Kothi (no 54), Tehsil Kotkhai has 10 shareholders in Khata no. 24. The khasra numbers, area, land classification, distance from road, shares of various shareholders and other relevant details in this Khataare available in Table 1 and 2, given later.
2. One of the shareholders, Badri Sain has applied for partition of the joint holding under the provisions of the HP Land Revenue Act, 1954 on 10.01.2021. He has attached all relevant documents for this purpose.
3. The AC Grade I, Tehsil Kotkhai follows the procedure laid down in para 14.5 of Chapter 14 of the Land Records Manual as notified on 26th June, 2012, on receipt of the application. Being satisfied that all is in order, the application is admitted for further processing. Summons / proclamation are issued to inform all shareholders as per available addresses and whatsapp numbers to come present on the next date of hearing. Badri Sain, Narain Das, Hukmi Ram, Savitri Devi and Kangu Devi are present in person. Paras Ram, Devinder and Mast Ram are represented by their power of attorney. Sarla Devi and Kanta Devi are not present. Since that last two have also received their summons / whatsapp messages, all parties are considered to have been served. Order is passed recording the position.
4. The AC Grade I then proceeds as required under para 14.6 to hear the parties present. Only three parties present raise objections. Narain Das states that the current entry regarding his share is erroneous since the missal haqiyat drawn up at the time of last settlement shows a larger share in the name of his predecessor in interest. He presents a copy of the same in support of his contention. On enquiry it is seen that revised share is indicated in the first jamabandi after digitization of land records. It is the result of computerized totalling bringing out an error in the numbers shown in themisalhaqiyat and subsequent jamabadis. The correction has been duly carried out through laid down procedure. The entry is now appearing for the last 3 jamabandis without any objection. The second objector Hukmi Ram states that he has purchased an additional area from another shareholder Savitri Devi and the mutation has not been attested as yet. He produces registration papers which are not disputed by Savitri Devi. A note to this effect is also available in the jamabandi. The third objector Kangu Devi states that while she is a shareholder in the khata and the record states that possession is of all shareholders she is wholly in possession of Khasra no. 103 comprising 600 square metres. She has constructed a house on the same since very long. She has acquired rights by way of adverse possession and therefore, there is a question of title involved. The AC Grade passes

an appropriate order holding that in view of the facts of the case and the law in such matters, the partition can proceed with a suitable amendment to take into account Hukmi Ram's increased share. The plea of question of title is also rejected and it is held that the shareholder will be free to seek protection of her possession in view of the provisions of para 14.10 which enable taking into account any specific possession and asset creation by a specific shareholder.

5. The above order having attained finality since no appeal is filed, the report of the Kanungo under para 14.9 is called for and duly received. It brings out the following situation.

Additional information contained in Kanungo's report:

- (i) All orchard area has similar density and age of fruit bearing trees. Similar investment has been made by all those in possession in planting 4 trees per 100 square metres of land. Net present value of fruit bearing trees currently estimated @ 1 lakh per tree by technical experts.
 - (ii) All houses have been built by those in possession at a similar cost at around the same time. The ratio of built up area to land area of the plot is 1: 3 in all cases. Built up area is valued by technical experts at Rs 1000 per square metre.
 - (iii) The tank on khasra number 110 has been constructed by the owner in possession. The current value has been estimated by technical experts at Rs 10,000 per square metre of land in the plot.
 - (iv) Sarla Devi is agreeable to accepting appropriate monetary compensation for any shortfall in receiving her share of land, if other shareholders are willing to pay.
 - (v) Kanta Devi is willing to pay for any additional amount required from her to compensate for investment made by others but would like to get her share of the land.
 - (vi) All shareholders are agreed that khasra number 102 comprising a common path should be maintained in common possession with proportionate reduction in area of each shareholder based on the shares as given in Table 1.
 - vii) There are no special conditions attached to partition in the revenue estate.
6. Based on the information received, the AC Grade I draws up a list of issues to be addressed and a mode partition which describes the guidelines he will follow in carrying out the partition, as required in para 14.10.
 7. The order of 14.10 is not challenged by any shareholder and the period for appeal having expired, the AC Grade I proceeds to draw up a draft Instrument of Partition showing all values and their apportionment and communicates to all parties as required under para 14.11. No objection is received and the period of appeal having expired, the Instrument of Partition is finalised as required under para 14.12.
 8. **In view of the position given above, passappealable speaking orders (in writing) rejecting the objections and question of title raised (15 marks), drawing up the list of issues and mode of partition (25 marks) and the final instrument of partition (60 marks).**
