NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor, Himachal pradesh, in consultation with the Himachal Pradesh, Public Service Commission is pleased to make the following rules further to amend the H.P. Departmental Examination Rules, 1997, notified vide this Department's Notification No. per (Training) B(12) -40/95, dated the 13th March, 1997, namely: -

- short title and 1. (i) These Rules shall be called the Himachal Pradesh Departmental Examination (Second commencement. Amendment) Rule, 1998.
 - (ii) These Rules shall come into force from the date of publication in Himachal Pradesh Rajpatra.
- Amendment of Rule2.
- After clause (Iv) before clause (v) of subrule (2) of Rule 2, of the H.P. Departmental Examination Rules, 1997 (hereinafter referred 2. the said rules) following clause (v) shall be inserted namely:-
 - "(v) All Superintendents Grade-II and Senior Assistants Class-III (Non-Gazetted) working under the Himachal Pradesh Government. Thereafter the existing clause (v) shall be re-numbered as (vi) .

Amendment of . Rule 7.

After the existing sub-rule (7) of Rule 7, of the said rules the following new sub rule (8) shall be added namely: -

and Senuor Assistant, Class-III (Non Gazetted) appointed to the non-jazetted services of the Stte of Himachal Pradesh by promotion or by direct recruitment or by any other method of recruitment shall be eligible to appear in the separtmental examination under these rules irrespective of the fact whether departmental examination has been prescribed in their respective recruitment and promotion Rules or not ".

4. After Rule 19 of the said rules, following Rule 19-A shall be inserted, namely:-

under these rules to the categories of employees as specified in clause (v) of sub rule (2) of rule 2 shall be treated as optional Examination but every such member shall be entitled for the grant of T.A./Leave etc. and the period spent for appearing in departmental examination will be treated as duty as per provisions of Rule 19".

Rule 21of the said rules, the following second and third provisos shall be
added as under, namely:

Provided further that any employee falling under the category as specified in clause (v) of sub-rule(2) of Rule 2 who passes the demartmental examination under these rules shall not be required to pass the departmental examination under these Rules on his appointment/promotion to the Gazetted post as specified in clause (iv) of sub-rule (2) of rule-2".

6. The existing sub-rule (2) of Rule 23 of the said rules, shall be substituted as under, namelys-

"A gazetted officer on the attainment of 56 years of age shall not be required to appear in the departmental examination prescribed under these n rules, as amendmed from time to time for the purpose of crossing the Efficiency Bar/Proficiency Step-up/Higher for Scale next due and confirmation in the service. However, the Gazetted Officers who have co crossed the age of 55 years shall not be required to pass the repartmental Examination prescribed under these rules for the purpose of further promotion". In the first and fourth lines of sub-rule (3) of rule 24, of the said rules, after the word" Officers", the following sign and word shall be inserted; namely:-
