## "OFFICE ORDER"

The circulation of tentative seniority list of TGT (NM/M) who were selected through HPSSSB (2002) and appointed in the year 2008&2009 in view of the order passed by the Hon'ble High Court in CWP No. 1811/2008 dated 14.11.2011 and other connected matters various association and individuals of all stream of TGT (M/NM/Arts) categories have raised certain issues regarding their seniority and representing to this Directorate to finalize their seniority w.e.f. 2002 in view of DOP&T Govt. of India OM. Dated 04.03.2014 adopted and circulated by the Department of Personal H.P. on dated 16.5.2014.

The matter was discussed and examined in the Department at length and it was decided that the entire selection process of TGTs of all categories (M/NM/Arts) who were selected by HPSSSB in 2002 was quashed by the Govt. in the year 2003 vide letter of dated 29.07.2003 and no appointments were made. These vacancies were again notified in the year 2006 and appointments were made after following due selection process. The State Govt. in 2007, have agreed in principal to offer appointments to those whose selection process was stopped in 2002 and later on quashed in 2003, this Govt. had given them appointments based on the vacancies notified in the year 2008. Feeling aggrieved with contractual appointments, they filed various petitions in the Hon'ble Court of H.P. against appointment. Hon'ble Court in its common judgment in contractual CWP No. 1811/2008-Des Raj v/s State of H.P. had adjudicated that they should be given regular appointments/seniority from the date they have been offered contractual appointment. Accordingly they were given appointments and the department has allotted seniority number to all TGTs appointed 2008/2009 and 2012 strictly in-view of order of the Hon,ble Hogh Court shall be governed as per the merit list of HPSSSB.

In the light of above background representation of all these TGT association/individuals demanding seniority from 2002 is not tenable vis-a-vis OM of DOP&T dated 04.03.2014 because all the selection process was quashed and

fresh vacancies/appointments were made in the year 2004/2006. Hence their demands to re-fix seniority from the year 2002 cannot be considered.
