ORDER

Sh. Rakesh Chand TGT (Arts) GSSS Sholi (SML) has filed CWP No. 4901/2021- before the Hon'ble High Court .The case was listed on 9.9.2021,when the same has been disposed of with the following directions:-

The instant petition is disposed of by permitting the petitioner to make a representation within a period of one week today and in case such representation is made, the same shall be considered by the respondents within two weeks.

In pursuance to order ibid, dated 9.9.21, passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Sh. Rakesh Chand TGT (Arts) has filed representation which has been received on 14.9.2021. After bare perusal of the representation we have noticed that the petitioner has mentioned following schools in Hamirpur Distt.for adjustment:-

We have examined the case of the petitioner carefully and noticed that the petitioner is working on contract basis since 23.1.2019 and has not completed normal tenure. However, unfortunately he is suffering from chronic kidney disease stage -V(BD-UK) and is under regular treatment from PGI Chandigarh.

As is evident from the table above, there is no longer stayee in the desired schools. However, the petitioner has also requested for transfer in GHS Booni (HMR) against vacancy on account of retirement on 30.11.21 vide representation dated 21.9.21 . Since one Smt. Neelam Kumari TGT (Arts) GHS Booni (HMR) is on the verge of retirement on 30.11.2021 , hence the petitioner is hereby adjusted without TTA/JT in GHS Booni (HMR) (keeping-in-view his ailment) against vacancy which will accrue on 30.11.2021. The petitioner will join after 30.11.2021.

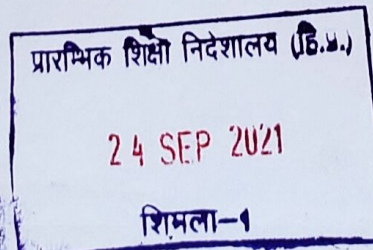
Accordingly representation stands decided.
