

In the matter of: CWP No:543/2020----titled as Prince Kumar Sharma Vs. State of H.P.

ORDER

Sh. Prince Kumar TGT (A) presently working in GSSS Kothi Kohar (KGR) has filed CWP No. 543/20209 before the Hon'ble High Court regarding transfer from the present school.. CWP was disposed of on 16.3.20 with the following directions:-

*The Petitioner has served in a tribal/difficult/sub cadre area and has completed more than his normal tenure of service on 21.11.16. The petitioner in terms of the transfer policy is entitled to be posted in a soft area as a matter of right. Consequently, the present petition is allowed and the respondent are directed to consider the case of the petitioner for transfer in any soft area that may be opted by him, out of one essentially may be in a different district. Such representation shall be made by the petitioner positively within one week from today and thereafter, the respondents shall consider the same within a further period of four weeks and pass consequential orders of transfer.*

Petition is allowed and disposed of in the aforesaid terms leaving the parties to bear their own costs. Pending application(s), if any, shall also stand disposed of accordingly.

The petitioner submitted representation vide dated 22.3.20 wherein he has requested for transfer in any one of the following schools:-

- 1.GMS Dar u/c GSSS Kashmir(HMR)
- 2.GBSSS Hamirpur(HMR)
- 3.GHS Kanjian (HMR)
- 4.GSSS Balduhak (HMR)
- 5.GSSS Jhagriani(HMR)
- 6.GGHS Dhaneta(HMR)

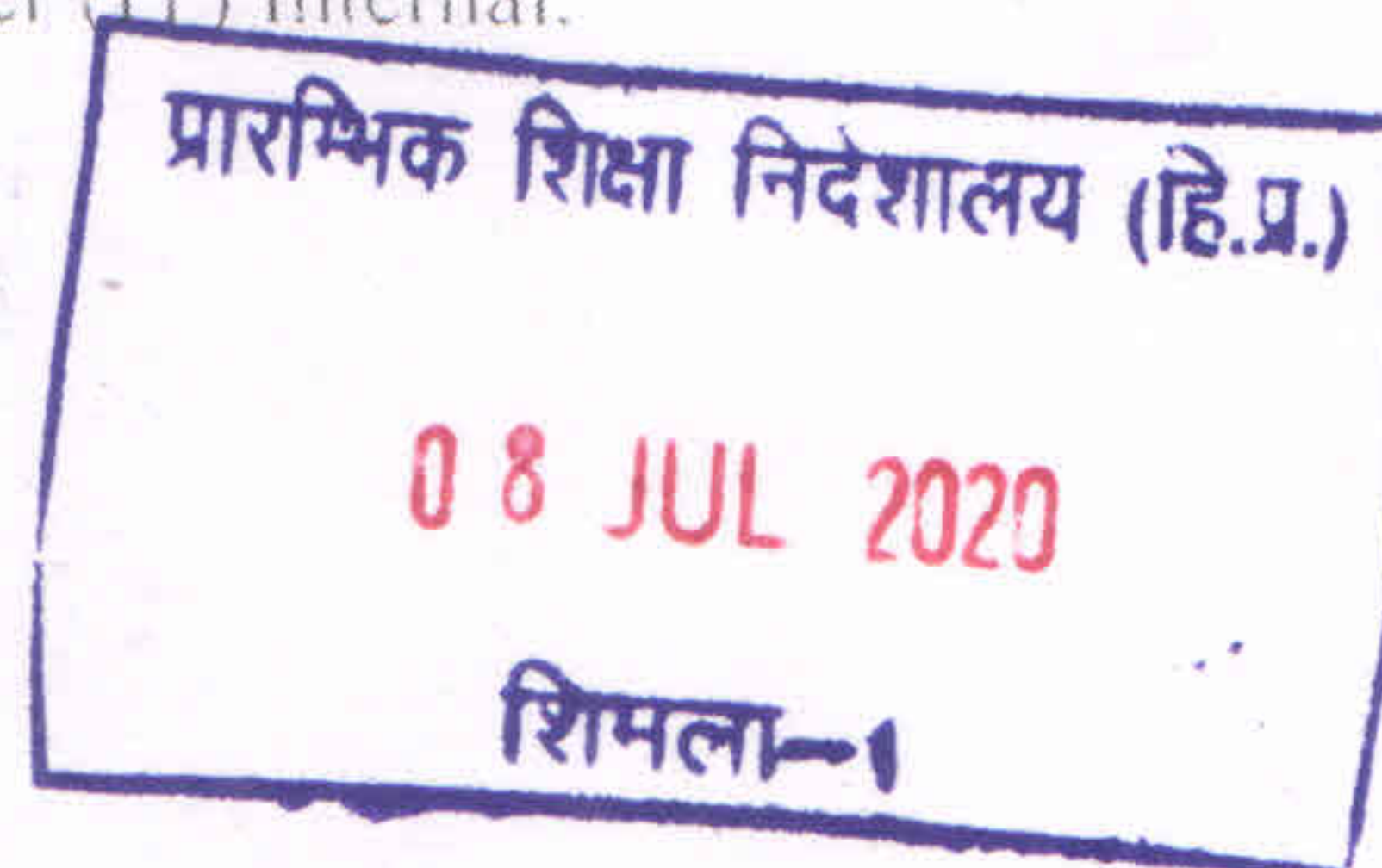
From perusal of record it has been noticed that the petitioner is working in GSSS Kothi Kohar (KGR) w.e.f. 21.11.16 which exists in sub cadre area . As per transfer policy a TGT can be transferred from sub cadre/ tribal area to soft area without substitute only after completion of 4 years and with substitute after 3 years. The petitioner has completed 3 years in GSSS Kothi Kohar (KGR) hence he is here by adjusted in GSSS Ambera (Una) against vacancy as there is no vacancy in the schools as mentioned by the petitioner. Substitute will be provided shortly by way of new recruitment.

Accordingly, representation stands decided.
