Regarding implementation of age criteria for admission to Class Nursury to Subject:-Class-1<sup>st</sup> as per NEP, 2020.

Sir,

In continuation to this department's letter of even number dated 24-11-2023, 16-02-2024 and 29-08-2024 on the subject cited above, I am directed to convey that the matter regarding relaxation in age criteria to already enrolled students was under consideration of the Government for past some time. After careful consideration, revised instructions/guidelines for adoption of age criteria as per NEP, 2020 shall be as under :-

(i) The age criteria for admission to Class Nursery/Balvatika-1 will be 3+ years

- w.e.f. academic session 2024-25. Thus, a child must be 3+ years old as on 31<sup>st</sup> March of academic year in which admission is sought for Class Nursery/Balvatika-1 w.e.f. 2024-25 onwards. This proposal will gradually ensure (after 3 years) that a Child will be admitted in Class-1st at the age of
  - (ii) Pre-school admission will be regulated as per NEP structure and following e criteria shall be implemented :-

Grade	Nursery/ Balvatika-1	LKG(Lower Kindergarten)/ Balvatika-2	UKG(Upper Kindergarten)/ Balvatika-3
		A1	5+years
Age	3+ years	4+ years	1

However, the above criteria will not be applicable for children already enrolled during the academic session 2023-24.

(iii) All those students who were already enrolled in Nursery/Balvatika-1, LKG/Balvatika-2, and UKG/Balvatika-3 for the academic year 2023-24 shall be granted admission to the next higher classes irrespective of their ages. This relaxation will be granted for the academic years 2024-25, 2025-26 & 2026-27 only. Thereafter, admissions will be strictly regulated as per NEP, 2020 as given in para (ii) above.

## However, to clarify :-

There will be no relaxation if a child of less than 3 years of age has been enrolled in Nursery/Balvatika-1 for the session 2024-25, as the Government had issued direction about age criteria on 16-02-2024 and thus, such a case is violation of Government's directions.

(iv) From the academic session 2027-28 onwards, the age criteria for admission to Class 1<sup>st</sup>/ Grade-1 will be 6+ years, as on cut-off date i.e 31<sup>st</sup> March of respective year.

You are, therefore, requested to take further necessary action in the matter accordingly.
