Whereas, Sh. Karnail Singh, TGT (NM) presently working in GMS, Greema u/c GSSS, Khani, Distt. Chamba (Tribal Area) has filed CWP No. 3357/2019- titled as Sh. Karnail Singh Vs. State of Himachal Pradesh before the Hon'ble High Court H.P., seeking the relief regarding transfer / adjustment against vacancy in Distt. Kangra. The case of the applicant was listed before the Hon'ble High Court on 23.12.2020, when after hearing the matter the Hon'ble High Court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

“Considering the undisputed fact that the petitioner has been serving in the hard area w.e.f 27.01.2014 for a period more than six year against the normal stay of two winters and three summers, we direct the respondents to consider transferring the petitioner as TGT (Non-Medical) to Government Middle School Takhnar u/c Government Senior secondary school, Bhali, District Kangra, H.P., with effect from the date, the present incumbent Mr. Kewal Singh, who has been promoted vide order dated 17<sup>th</sup> December, 2020 and his name find mention at Sr. No. 234 of the said order is relieved. Such order be passed without any further delay.”

Given above, the writ petition is allowed in the aforesaid terms. Pending application(s) if any, are closed

Whereas, Sh. Karnail Singh, TGT (NM) was working in GMS, Greema u/c GSSS, Khani, Distt. Chamba (Tribal Area) and after completion of his normal tenure and in compliance with the direction of Hon'ble High Court, Sh. Karnail Singh, TGT (NM) is hereby transferred from GMS, Greema u/c GSSS, Khani Distt. Chamba to GMS, Takhnar u/c GSSS Bagli Distt. Kangra against vacancy without TTA/JT. The representation of the applicant is disposed of accordingly.
