ORDER

In the matter : CWP No. 4816/ 2021- Het Ram,TGT(Med) Vs State of H.P. & others (Regarding transfer)

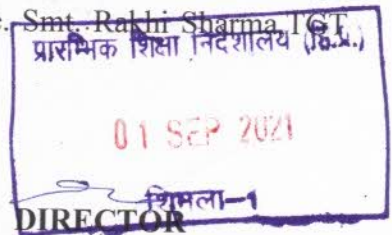
The Petitioner Sh. Het Ram has filed CWP No. 4816/2021 titled as Sh.Het Ram ,TGT (M) versus State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GHS Hango Distt. Kinnaur , H.P. to his choice of station after the completion of required tenure as per policy. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 25th August 2021 when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

" After arguing the matter for some time learned counsel for the petitioner restricts his plea for a direction to the respondent No.2 to consider the representation ,vide Annexure P-1, since the same has not been considered as on date. Respondents have no objection to the same.

In view of the above , the petition is disposed off, with a direction to the respondent No. 2 to consider the representation of the petitioner (Annexure P-1), within a period of one week from today."

The representation of the petitioner shows that he was initially appointed as TGT (Med) on 06th May 2017, in GHS Hango Distt. Kinnaur, which is a tribal area of the State and the petitioner is continuing to work there till date. Since the father of the petitioner has suffered severe fracture in femur bone and he is unable to move, the petitioner has requested for his transfer to some station near to his home i.e. somewhere in District Hamirpur, Distt. Bilaspur, Una or the areas of District Kangra which are adjacent to District Hamirpur.

On perusal of record pertaining to the case shows that Sh. Het Ram,TGT (Med) is working in GHS Hango Distt. Kinnaur since 6th May 2017 and has completed his normal tenure at present place of posting. Hence keeping in view his adverse family circumstances the petitioner is hereby transferred from GHS Hango Distt. Kinnaur to GSSS Galore against longer stayee i.e. Smt. Rakhi Sharma TGT (Med), with TTA/JT.


