ORDER

CWP No. 7409/2021 titled as Pooja Rani Vs State of H.P.& others.(Regarding transfer)

The Petitioner Smt. Pooja Rani has filed CWP No. 7409/2021 titled as Smt. Pooja Rani, TGT (M) versus State of H.P. before the Hon'ble High Court of H.P. aggrieved her transfer from GSSS Duhak(KGR) to GHS Chowki(KGR) vice Smt. Anuradha Sood ,TGT(Med). The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 17th Dec.2021 when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

"(i) that the impugned transfer order dated 23-11-2021 (Annexure P-1) may kindly be quashed and set aside.

(ii) issue a writ of mandamus directing the respondent No.2 allow the petitioner to continue in the present school till she completes normal tenure on regular basis or in the alternate to post the couple at one place."

" In view of this, we permit respondent No.3 to file a representation before the competent authority within a week from today and the same shall be considered and decided sympathetically by the competent authority within two weeks thereafter."

As per the order passed by the Hon'ble Court the Respondent No 3 i.e Smt. Anuradha Sood, TGT, (Med) made a representation to the undersigned on 17-01-2022, requesting therein for her adjustment against longer stayee in GHS Thandol, GSSS Chandpur, GSSS Thural Distt. Kangra, H.P.

The representation has been examined carefully and it has been revealed that the petitioner has been transferred from GSSS Duhak(KGR) to GHS Chowki(KGR) vice Respondent No. 3 i.e. Smt. Anuradha Sood, TGT(M) & vice-versa on the completion of normal tenure of three years as per policy. Now, in compliance to the orders passed by the Hon'ble High Court in aforesaid writ petition the representation of the respondent No. 3 is considered sympathetically and she is hereby adjusted at GSSS Thural Distt. Kangra, vice Smt. Sanjeevna, TGT, (Med), with TTA/JT. With these observations the representation of the Respondent No. 3 is considered and disposed of accordingly.
