Shri Anil Kumar, TGT (NM) preferred CWP No. 7700/2021- titled as Anil Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from Govt. Sr. Sechondary School Nigulsari District Kinnaur (Hard Area) to District Hamirpur/Bilaspur(Soft area). The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 6.12.2022 when the Hon'ble High Court has passed the following orders:-

"...3. Accordingly, without adverting to the merits of the case, we deem it appropriate to dispose of the writ petition by giving liberty to the petitioner to move a fresh representation to respondent No. 2 in terms of the Comprehensive Guiding Principales, dated 10th July, 2013, within a week from today. Respondent No. 2 is directed to dispose of the said representation within fifteen days from its receipt alongwith copy of this order.

Pending miscellaneous application(s), if any, also stand disposed of."

In compliance to the directions of the Hon'ble High Court the petitioner submitted his representation in this Directorate on 13.12.2021. He was called for personal hearing on 1.02.2022 and he attended the same. He has given five stations of his choice for his transfer from hard area to soft area.

From perusal of record, it has been found that the petitioner is working in GSSS Nigulsari District Kinnaur since 31.8.2018 and completed three years stay in hara/tribal area. The petitioner has given five stations in which no post of TGT(NM) is lying vacant. However, one Smt. Sushma Rani, TGT(NM) is working in GSSS Lower Hareta District Hamirpur and has completed three years stay there. She has not served in hard/ tribal area. Keeping in view of the above position the representation of the petitioner is considered and he is hereby transferred from GSSS Nigulsari Distrcit Kinnaur to GSSS Lower Hareta District Hamirpur vice Smt. Sushma Rani, TGT(NM) & vice-versa, with TTA/JT to Smt. Sushma Rani, TGT(NM). The representation of the petitioner is disposed of accordingly.
