In the matter of: CWP No. 7635/2021 titled as Anil Kumar Vs. State of H.P. & Others.

Shri Anil Kumar, TGT (NM) preferred CWP No. 7635/2021-titled as Anil Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from Govt. Middle School Chet u/c Govt. Sr. Sechondary School Chiuni District Mandi to District Kangra. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 3.12.2021 when the Hon'ble High Court has passed the following orders:-

"...4. Accordingly, without adverting to the merits of the case, we deem it appropriate to dispose of the writ petition by directing the petitioner to move an appropriate representation in terms of the guidelines made in the Transfer Policy, to respondent No. 2 within one week from today and respondent No. 2 shall dispose of the same within fifteen days of receipt of copy of the representation alongwith copy of this order. Pending miscellaneous application(s), if any, also stands disposed of."

In compliance to the directions of the Hon'ble High Court the petitioner submitted his representation in this Directorate on 06.01.2022. He has given six stations of his choice for his transfer in District Kangra and one station of District Mandi.

From perusal of record, it has been found that the petitioner is working in GMS Chet u/c GSSS Chiuni District Mandi since 5.09.2018 and has completed more than three years stay. The petitioner has given seven stations in which no post of TGT(NM) is lying vacant. However, one Smt. Mamta, TGT(NM) is working in GMS Haldra u/c GSSS Dhatti (Kangra) since 6.03.2017 and has completed more than four years stay. She has never served in hard/sub-cadre area in her entire service career. Keeping in view of the above position the representation of the petitioner is considered and he is hereby transferred from GMS Chet u/c GSSS Chiuni District Mandi to GMS Haldra u/c GSSS Dhatti District Kangra vice Smt. Mamta, TGT(NM) & vice-versa, with TTA/JT to Smt. Mamta, TGT(NM). The representation of the petitioner is disposed of accordingly.

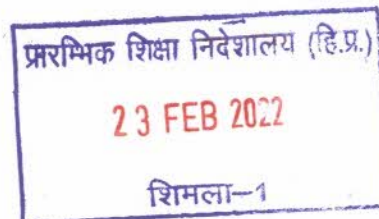
