Whereas, Shri Sanjay Kumar, TGT (NM) preferred CWP No. 157/2022 titled as Sanjay Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Bandal u/c GSSS Bhatgarh District Sirmour (Hard Area) to District Kangra/Una in soft area. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 6.1.2022 when the Hon'ble High Court has passed the following orders:-

"...4. Accordingly, without advertng to the merits of the case, this writ petition is disposed of by giving liberty to the petitioner to approach respondent No. 2 by making a fresh representation, in terms of transfer policy dated 10.7.2013, within a week from today and in case the petitioner moves such representation, then respondent No. 2 is directed to consider and dispose of the same, in accordance with law, within two weeks form the date of receipt of the same along with a copy of this order.

Pending application(s), if any, shall also stand disposed of"

In the compliance the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 14.3.2022. He attended the same and requested his transfer from hard area to his native place i.e. District Kangra.

Whereas, from perusal of record, it has been found that the petitioner is working in GMS Bandal u/c GSSS Bhatgarh District Sirmour since 04.10.2017 and has completed more than three years stay there. The petitioner is working in hard/sub-cadre area of Sirmour District and is entitled for transfer at the station of his choice as per policy. The petitioner has requested in his representation at the time of hearing that he may be transferred to GMS Balol u/c GSSS Sunhi District Kangra against vacancy likely to be arisen on the retirement of the present incumbent on 30.4.2022. Keeping in view of the above position, the representation of the petitioner is considered and he is hereby transferred from GMS Bandal u/c GSSS Bhatgarh District Sirmour to GMS Balol u/c GSSS Sunhi District Kangra against vacancy being caused due to retirement of the present incumbent on 30.4.2022. These orders will be implemented after the retirement of the present incumbent i.e. 30.4.2022. The representation of the petitioner is disposed of accordingly.
