ORDER

Sh. Om Prakash, TGT(Arts) has filed CWP No. 1569/2022-before the Hon'ble High Court regarding transfer from GSSS Hallan, Distt. Sirmour to GMS Sharog u/c GSSS Sholi, Distt. Shimla. The case was listed on 23.02.2022, when the same has been disposed of with the following directions:-

The petitioner to make a representation clearly setting out therein five stations of his choice out of which one essentially should be out of his home district. In the event of such representation being made, the respondents shall consider and decide the same and thereafter consequential orders of transfer and posting of the petitioner be passed within one week after making the representation. Till such time, the petitioner shall not be compelled to join the transferred station. Pending applications, if any, also stand disposed of.

In pursuance to the orders passed by the Hon'ble High Court of Himachal Pradesh, petitioner i.e Sh. Om Prakash, TGT (Arts) has submitted representation and requested for adjustment in GMS Goway u/c GSSS Dhar Chandna/ GMS Samvi u/c GSSS Tikker/GHS Bag/ GSSS Tikker, Dist. Shimla/ GSSS Solan/GMS Shamti, Distt.Solan, against vacancy.

On the perusal of record, it is found that Sh. Om Prakash, TGT (Arts) is working in GSSS Hallan, Distt.Sirmour since 22.3.2018 and has completed more than four years at the present place of posting. He was transferred from GSSS Hallan (SMR) to GMS Sharog u/c GSSS Sholi, Distt.Shimla, with the prior approval of the competent authority. At present posts of TGT(Arts) are lying vacant in GMS Goway/GMS Samvi/GHS Bag/GSSS Tikker, Distt.Shimla. However the highest enrolment is 58 students studying in GHS Bag, Distt. Shimla where post of TGT (NM) is also lying vacant.

In view of facts stated above, representation of petitioner i.e. Sh. Om Prakash, TGT(Arts) who is under orders of transfer from GSSS Hallan, Distt. Sirmour to GMS Sharog u/c GSSS Sholi, Distt.Shimla is considered sympathetically and he is hereby adjusted at GHS Bag u/c GSSS Gounth, Distt. Shimla, against vacancy.

Accordingly representation stands decided.
