**ORDER**

Sh. Naresh Kumar, TGT(Arts) has filed CWP No. 1709/2022-before the Hon'ble High Court regarding transfer from GSSS Tandu, Distt.Mandi. The case was listed on 25.03.2022, when the same has been disposed of with the following directions:-

*The petitioner to make a comprehensive representation to respondent No. 2- Director Elementary Education, Shimla within a period of one week from today, who shall consider and decide the representation of the petitioner within a period of 15 days from the date of production of a copy of this order. Pending applications, if any, also stand disposed of.*

In pursuance to the orders passed by the Hon'ble High Court of Himachal Pradesh, petitioner i.e Sh. Naresh Kumar, TGT(Arts) TGT (Arts) has submitted representation vide which he stated that his daughter is about one and half years old and wife is also a Government servant presently posted as Staff Nurse at Zonal Hospital Mandi. He has requested that due to adverse family circumstances and couple case, he may kindly be adjusted in GSSS Dhar/ GMS Sandhole u/c GSSS Katindi/ GSSS Bir Tungal/GSSS Gharan/GHS Drang, Distt.Mandi/ GSSS Kandror.

On the perusal of record, it is found that Sh. Naresh Kumar, TGT (Arts) was transferred from GSSS Tandu, Distt. Mandi to GMS Kachi Ghati u/c GSSS Tutikandi Distt.Shimla, with the prior approval of the competent authority. As per para 5.4 of the comprehensive Guiding Principles-2013 "***In case wife and husband both are working under the State Government efforts be made to post them at one place of near places as far as possible subject to vacancy.***"

In view of facts stated above, representation of petitioner i.e. Sh.Naresh Kumar, TGT(Arts) who is under orders of transfer from from GSSS Tandu, Distt. Mandi to GMS Kachi Ghati u/c GSSS Tutikandi, Distt.Shimla is considered sympathetically and he is hereby adjusted at GSSS Dhar, Distt. Mandi, against vacancy, without TTA/JT.

Accordingly representation stands decided.
