(Regarding Transfer)

ORDER

Sh. Maha Raj, TGT (Arts) has filed CWP No. 1504/2022-before the Hon'ble High Court of H.P. regarding his transfer from GSSS Darkali, Distt. Shimla to District Kangra in his home district. The case was listed on 17-03-2022, when the same has been disposed of with the following directions:-

..... 2. Without expressing any opinion on the merits of the case and also observing that it is the prerogative of the employer where the Government Servant should be posted, we dispose of the present writ petition with direction to the ~~The~~ Director Elementary Education, Shimla to consider and convey the decision on the representations within a period of four weeks, in accordance with law, from the date of production of a copy of this order before him.

..... 3. Pending applications, if any, also stand disposed of.

In pursuance to the orders passed by the Hon'ble High Court of Himachal Pradesh, petitioner i.e Sh. Maha Raj, TGT (Arts) has submitted representation and requested for transfer from GSSS Darkali Distt. Shimla to GSSS Tamber/ GSSS Palampur/GSSS Banuri/GMS Saperu u/c GSSS Kandbari (Kangra)/ GMS Ghatta (Mandi)/ GSSS Matour Distt. Kangra against vacancy, being caused due to retirement of present incumbent on 30-04-2022.

On the perusal of record, it is found that petitioner i.e. Sh. Maha Raj, TGT (Arts) is working in GSSS Darkali Distt. Shmla (which is in sub-cadre) since 28-01-2019 and has completed his normal tenure at present place of posting. At present posts of TGT(Arts) are not lying vacant in the above mentioned schools. Post of TGT (Arts) is going to be vacant at GSSS Matour, District Kangra, being caused due to retirement of present incumbent on 30-04-2022.

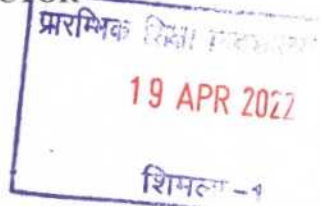
In view of facts stated above, representation of petitioner i.e. Sh. Maha Raj, TGT (Arts) is considered sympathetically and he is hereby transferred from GSSS Darkali Distt. Shimla to GSSS Matour, District Kangra, against vacancy, being caused due to retirement of present incumbent. The petitioner will join after superannuation of present incumbent i.e. after 30-04-2022,

Accordingly representation stands decided.
