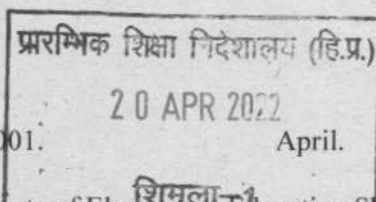
In the matter : CWP No. 1487/2022- Rajeev Rana,TGT(Med) Vs State of H.P. & others (Regarding transfer)

The Petitioner Sh. Rajeev Rana,TGT(Med), filed CWP No. 1487/2022 titled as Sh. Rajeev Rana Vs State of H.P. before the Hon'ble High Court of H.P.regarding his transfer from GSSS Rupri 15/20 (Nihar) Distt. Kinnaur (which fall under tribal hard area) to his choice of station after the completion of required tenure as per policy.The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 16<sup>th</sup> March,2022, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

*" Accordingly , without advertng to the merits of the case, this writ petition is disposed of with a direction that in case the petitioner moves a representation to the respondent in terms of the transfer policy,dated 10<sup>th</sup> July,2013,within a week from today ,then respondent shall dispose of the same within two weeks from the receipt of the representation in accordance with law."*

As per direction of the Hon'ble High Court the petitioner was called for personel hearing on dated 11-04-2022. He represented to this office regarding his representation he may be adjusted in GSSS Atiyala Dai, GSSS Gander/ GHS Barram/ GSSS Lower Lambagaon, GHS Bairghata Distt. Kangra / GBSSS Sujanpur Distt. Hamirpur against vacancy or longer stayee.

From the perusal of the record, it reveals that Sh. Rajeev Rana ,TGT(Med) has been working in GSSS Rupri 15/20(Nihar) (which falls under tribal / hard area) Distt. Kinnaur since 14<sup>th</sup> March.2019 and has completed his normal tenure at present place of posting.The petitioner has given five stations of his choice, four in Distt. Kangra and One of Distt. Hamirpur. One Smt. Sarita Devi,TGT(Med) is working in GSSS Gander Distt.Kangra since 09-06-2006,(on PTA basis and regularized in same school), has completed her normal tenure at present place of posting .She has never served in hard/Tribal area. Keeping in view the position stated above the petitioner is hereby transferred from GSSS Rupri 15/20 (Nihar) Distt. Kinnaur to GSSS Gander Distt.Kangra vice Smt.Sarita Devi,TGT(Med).The representation of the petitioner is disposed of accordingly.
