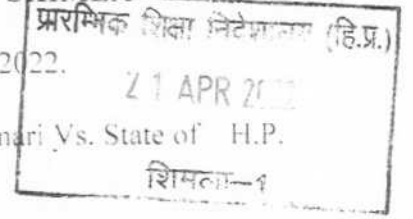

& Others.



Whereas, Smt. Anu Kumari, TGT (NM) preferred CWP No. 558/2022 titled as Anu Kumari Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS Lyh District Chamba (Hard Area) to District Kangra/Chamba(Soft Area). The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 4.2.2022 when the Hon'ble High Court has passed the following orders:-

3. In view of above, the instant petition is disposed of by ordering that the respondents concerned shall decide representation of the writ petitioner, Annexure P-1 dated 18.11.2021, within a period of three weeks from today and pass a reasoned order, in accordance with law.

However, it is made clear that, if the writ petitioner is still aggrieved, she has every right to approach this Court. Pending application(s), if any, also stands disposed of."

In the compliance of the aforesaid orders passed by the Hon'ble High Court, the petitioner was called for personal hearing on 28.2.2022 and she attended the same. At the time of hearing she stated that she has completed three years stay in hard/sub-cadre area and entitled to transfer for the station of her choice as per policy. She further requested that she may be adjusted at GHS Uschar (Kangra) against longer stay.

From perusal of record, it has been found that the petitioner is working in GSSS Lyh District Chamba since 13.9.2018 and has completed more than three years stay there. At present one Shri Vijay Kumar, TGT(NM) is working in GHS Uschar District Kangra since 10.12.2014 and has completed more than 7 years stay in his present place of posting. One Shri Rajesh Kumar, TGT(NM) working in GMS Kailashpur u/c GSSS Makol District Kangra since 5.11.2018 and has completed three years stay there and willing to transfer in place of the petitioner. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and she is hereby transferred from GSSS Lyh District Chamba to GHS Uschar District Kangra vice Shri Vijay Kumar, TGT(NM) who is further transferred without TTA/JT to GMS Kailashpur u/c GSSS Makol District Kangra vice Shri Rajesh Kumar, TGT(NM) who is further transferred to GSSS Lyh District Chamba in place of the petitioner, without TTA/JT. The representation of the petitioner is disposed of accordingly.
