(Regarding Transfer)

**ORDER**

Smt. Kusum Lata, TGT (Arts) has filed CWP No. 1881/2022-before the Hon'ble High Court of H.P. regarding her transfer from GSSS Cheuni to GHS Talehan(Mandi).The case was listed on 17-03-2022, when the same has been disposed of with the following directions:-

*The petitioner may approach the Director, Elementary Education, Himachal Pradesh, Shimla, asking him to review his order in view of the aforesaid condition by either retaining the petitioner at the same place or consider to post her at one of the station out of five stations of her choice to be given by her. The representation shall be filed within a week. If such representation is made within a week, the same shall be decided within a period of fifteen days.*

*The writ petition is disposed of accordingly, so also the pending miscellaneous applications, if any.*

In pursuance to the orders passed by the Hon'ble High Court of Himachal Pradesh, petitioner i.e Smt. Kusum Lata, TGT (Arts) has submitted representation vide which she stated that GSSS Cheuni exists in hard area and she has been again transferred to hard area i.e GHS Talehan (Mandi). She has requested for adjustment at GSSS Gohar/ GHS Kandha/GSSS Bagsaid/ GSSS Bara / GSSS Dhangiar, Distt. Mandi.

On the perusal of record, it is found that Smt. Kusum Lata, TGT (Arts) was transferred from GSSS Cheuni (Mandi) to GHS Talehan (Mandi) against vacancy, after completion of her normal tenure with the prior approval of the competent authority. The aforesaid school does not fall in hard area. However, one Sh. Maan Singh, TGT(Arts) is working in GSSS Dhangiar (Mandi) since 9.01.2019 and has completed his normal tenure at the present place of posting.

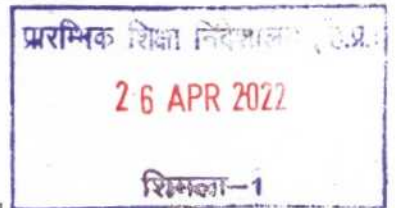
