ORDER

In the matter : CWP No. 2179/2022 titled as Arpana Devi,TGT(Med) Vs State of H.P. & others.

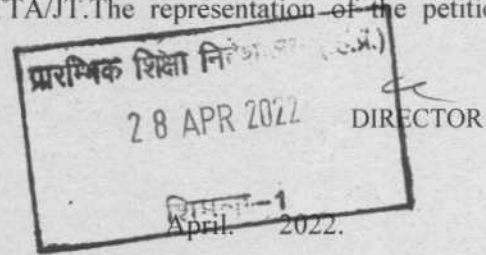
The Petitioner Smt. Arpana Devi ,filed CWP No. 2179/2022 titled as Smt. Arpana Devi,TGT(Med)versus State of H.P. agreed her transfer fromGSSS Masroor(KGR) to GHS kahri(CBA).The case of the petitioner was listed before the Hon'ble High Court on 08th March, 2022 ,when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

"It is admitted fact that petitioner has completed her tenure of three years at present place of posting ,therefore, in view of judgement passed by the Division Bench of this Court in CWP No.2624/2020,titled a Shabnam Vs state of Himachal Pradesh and others decided on 18th September ,2020 & CWP No.2138/2022,titeld as Roop Chand VS state of Himachal Pradesh & another,decided on 7th April,2022,we are not inclined to interfere in transfer of petitioner by passing a judicial orders.However,as prayed,petitioner is at liberty to make a representation to respondent No.2 on or before 11-04-2022 and in case such representation is preffered by petitioner ,the same shall be considered and decided by respondent No.2 wihin week,thereafter and till then petitioner shall not be compelled to join her next place of posting.It is made clear that it shall not operate as a stay agasint transfer of respondent No.3.

As the petitioner has represented through his advocate to this office that she may be adjusted in GSSS Haripur,GSSS Guler (Nagrota Surian) vice the incumbent working against the post of TGT(Med) and GSSS Surani or GSSS Katora u/c GSSS Spail Distt. Kangra against longer stayee. The Advocate has further stated that the petitioner is also suffering from weakness of brain nerves and is under treatment from Tanda Medical College and doctors has advised not to take stress.

The representation has been examined carefully and it has been revealed that the petitioner has been transferred from GSSS Masroor Distt. Kangra to GSSS Kahri Distt. Chamba vice respondent No.3 i.e. Smt. Savita Bala,TGT(M) & vice-versa on the completion of normal tenure of three years as per policy with the prior approval of the competent authority. Keeping in view of the position stated above the representation of the petitioner is considered sympathically and she is herby adjusted in GHS Katora u/c GSSS Spail Distt. Kangra without TTA/JT vice Smt.Sonu Devi,TGT(Med), with TTA/JT.The representation of the petitioner is disposed of accordingly.
