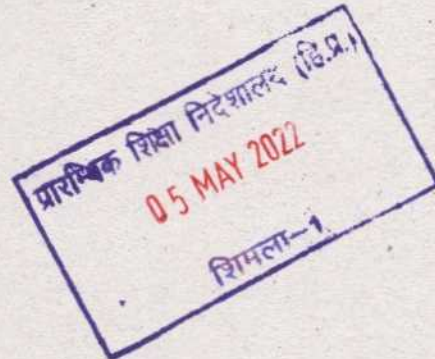

In the matter of: CWP No. 1529 /2022 titled as Sunil Kumar Vs. State of H.P. & Others.

Whereas, Shri Sunil Kumar, TGT (NM) preferred CWP No. 1529/2022 titled as Sunil Kumar, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Koot u/c GSSS Ganvi District Shimla (hard area) to the station of his choice in soft area. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 5.3.2022 when the Hon'ble High Court has passed the following orders:-

*" 4. Accordingly, without advertng to the merits of the case this writ petition is disposed of with a direction that in case the petitioner moves a fresh representation to respondent No. 2, in terms of the transfer policy, dated 10<sup>th</sup> July, 2013, within a weeks from today, then the said respondent shall dispose of the same within two weeks of the receipt of the representation, in accordance with law, Pending application(s), if any, also stand disposed of."*

In the compliance of the aforesaid orders passed by the Hon'ble High Court, the petitioner was called for personal hearing on 11.4.2022 and he attended the same. At the time of hearing he stated that he has completed three years stay in hard/sub-cadre area and entitled to transfer for the station of his choice as per policy. He further requested that he may be adjusted at the station of his choice.

From perusal of record, it has been found that the petitioner is working in GHS Koot u/c GSSS Ganvi District Shimla since 5.3.2019 and has completed more than three years stay at his present place of posting and entitled for his transfer to the station of his choice as per policy. At present one post of TGT(NM) is lying vacant in GMS Sai u/c GSSS Balera District Solan where the petitioner <sup>has</sup> given his willing for transfer. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred from GHS Koot u/c GSSS Ganvi District Shimla to GMS Sai u/c GSSS Balera District Solan against vacancy, without TTA/JT, on his own request. The representation of the petitioner is disposed of accordingly.
