ORDER

Sh. Rakesh Kumar, TGT (Arts) has filed CWP No. 1717/2022-before the Hon'ble High Court of H.P. regarding transfer from GSSS Giltari, Distt.Shimla. The case was listed on 28-03-2022, when the same has been disposed of with the following directions:-

The ~~the~~ respondents to consider the representation of the petitioner in their discretion and pass appropriate orders within a period of four weeks from the date a copy of this order is produced before them. The writ petition is disposed of accordingly, so also the pending miscellaneous applications, if any.

In pursuance to the orders passed by the Hon'ble High Court of Himachal Pradesh, petitioner i.e Sh. Rakesh Kumar, TGT(Arts) has submitted representation vide which ~~she~~ stated that he is an Ex-Serviceman and joined the department as TGT(Arts) at GSSS Giltari, Distt.Shimla which is 270 Km from his native place. He has further requested that he may kindly be transferred from GSSS Giltari, Distt.Shimla to GSSS Saroh(Una) /GSSS Rail/GHS Lanjiyana/GSSS Lower Hareta/GSSS Jhiralri (Hamirpur)/GSSS Budhan (Una).

On the perusal of record, it is found that Sh.Rakesh Kumar, TGT(Arts) is working in GSSS Gilatri,Distt.Shimla since 07.08.2017 and has completed his normal tenure at the present place of posting. At present post of TGT (Arts) is lying vacant in GSSS Saroh, Distt. Una .

Keeping in view the submissions made by the petitioner, i.e. Sh. Rakesh Kumar, TGT(Arts) is considered sympathetically and he is hereby transferred from GSSS Giltari, Distt. Shimla to GSSS Saroh, Distt.Una, against vacancy, without TTA/JT.

Accordingly representation stands decided.
